For Consideration herein acknowledged as received, and by signing this release I hereby give the Photographer the absolute, irrevocable, worldwide and perpetual right and permission to license and/or copyright the Content in the Photographer's own name or any other name that he may choose; to use my name or a fictitious name in connection with the Content; and to use, re-use, publish and re-publish the Content in whole or in part, individually or in conjunction with, but not limited to, other images, text, graphics, film, audio-visual works in any Media for any purpose whatsoever, including (but not by way of limitation) advertising, marketing, promotion, trade, stock photography and publishing.

I agree that I have no rights to the Content, and all rights to the Content belong to the Photographer. I waive any right to inspect or approve the finished Content, including the advertising copy, accompanying text, or any other printed or visual matter that may be used in conjunction therewith, or to inspect or approve any version of any use(s) to which the Content may be employed or used in conjunction therewith.

I hereby release and discharge the Photographer from any and all liabilities, claims and demands arising out of or relating to any blurring, distortion, or alteration whether intentional or otherwise, that may occur or be produced in connection with the Content, or in connection with any processing, alteration, transmission, display, or publication of the Content.

I acknowledge and agree that I have no further right to additional consideration or accounting, and that I will make no further claim for any reason to the Photographer.

It is agreed that my personal information noted herein with a "1" (i.e. Residence Address, Phone, Email), will not be made publicly available without my consent, but may be used where deemed necessary by the Photographer (e.g. to demonstrate or protect the Photographer's rights or in relation to the licensing of the Content) and may be retained as long as necessary to fulfill this purpose, including by being shared with other parties (including, but not limited to sub-licensees or assignees of the Photographer) and transferred to countries with differing data protection and privacy laws where it may be stored, accessed and used.

I represent that I am not affiliated with any model agent or agency and have made no other agreement, whether written or oral, pertaining to the creation, use or publication of any of the Content

In addition to the Photographer, this authorization and Release shall enure to the benefit of the legal representatives, licensees, successors, designees and Assigns of the Photographer as well as, the person(s)/entity for whom the Photographer took the Content.

This Release constitutes the sole, complete and exclusive agreement between the Photographer and me regarding the Content and I am not relying on any other representation whether oral or written. Once signed, this Release can only be modified if agreed to by the Photographer and me in writing. I agree that this Release shall be binding upon me, my heirs, legal representatives and assigns and is absolute, irrevocable, worldwide and perpetual, and will be governed by the laws of Manitoba, Canada. I acknowledge that I am eighteen years or older and have read this Release, fully understand the contents, terms and conditions contained in it and have received the copy of this Release.

**Definitions:** "ASSIGNS" means a person or any company to whom Photographer has assigned or licensed rights under this release as well as the licensees of any such person or company. "CONSIDERATION" means \$\_\_\_\_; and/or a minimum \_\_\_\_ jpg photos from the Content which the Photographer agrees to license to me for use in my portfolio or for my non-commercial use; or something else of value; for which I have received in exchange for the permission and rights granted by me in this Release. "CONTENT" means all photographs, film, audio, or other recording, still or moving, taken of me as part of the Shoot. "MEDIA" means all media including digital, electronic, print, television, film, radio and other media now known or to be invented. "MODEL" means me and includes my appearance, likeness and voice. "PARENT" means the parent and/or legal guardian of the Model. Parent and Model are referred to together as "I", "me" or "my" in this Release, as the context dictates. "PHOTOGRAPHER" means photographer, illustrator, filmmaker or cinematographer, or any other person or entity photographing or recording me and also includes the Photographer's successors, Assigns, designees, those acting under its authority, legal representatives, and/or those acting with its permission and authority. Photographer is referred to herein this Release, as the context dictates, as either "he" or "its". "SHOOT" means the photographic, film, video or recording session that occurred with the Photographer on the Shoot Date.
